## Government

Ripple Fiber has indicated that installation of its fiber optic cable will begin soon in the Lake neighborhoods. The cable is buried along the road rights of way, immediately (most times) off the pavement on the side of the street where utilities are already buried. Ripple is required to restore disturbed property to the condition it was in prior to construction, including repair of any irrigation lines or other buried service equipment that they damage. Ripple will provide flags so that homeowners can show the location of these things in their yards. The construction manager for Ripple's project is Susan Kitching, and she can be reached at 910-493-3587.

I have attended a presentation by Ripple and have made inquiry about installation at our property through the website. The presentation was reasonably informative, and Ripple was very responsive to my inquiry. That said, issues with damage to existing infrastructure are inevitable and have occurred already. Ripple has reportedly been responsive to those and have made repairs promptly and satisfactorily.

Finally, the service is reportedly faster and more reliable than Spectrum, and at least during this construction phase, those who sign up for the service will receive free installation and have their monthly charge fixed for life.



In other news, the Village has enacted a revised ordinance governing door-to-door solicitation. (Has there been a confirmed sighting of a door-to-door solicitor in Pinehurst?) Commercial solicitors must obtain a permit from the Village; noncommercial (i.e. political or religious) solicitors do not. Neither type of solicitation can be legally prohibited outright, however homeowners are not required to allow solicitation on their properties. For those residents who wish to do so, the Village has prepared "No Soliciting" stickers that can be placed on a front door, to deter the practice. I have a limited supply of these, and they can also be obtained from Village Hall.

Pinehurst Village Council has begun a process to revise the ordinances regulating unreasonable noise, lighting, unruly gatherings and short-term rental operations. The Village's noise ordinance has been amended to prohibit noise in excess of 65 dB between the hours of10:00 p.m. and 7:00 a.m. (In other words, the "ambient noise threshold" which made the previous ordinance largely unenforceable has been eliminated.) Complaints regarding noise in excess of this level may be reported to the Pinehurst Police at the Non-Emergency Dispatch number (910-295-3781). The police will assess and document the complaint and issue a citation if one is warranted.

Council also revised the regulations governing light pollution in residential neighborhoods, the purpose being to diminish lighting that "spills" over from one property to another. If you have an issue with this, please refer to Section 92.18 of the Village Municipal Code to find the limits on residential lighting, the complaint process and the penalties.

You can also contact Village Councilman John Taylor at jtaylor@vopnc.org or Councilwoman Barb Ficklin at bficklin@vopnc.org. They oversaw the revision of both the noise and the lighting ordinances. Both of them have proven to be very responsive to resident inquiries.

After completing these revisions, the Village will turn to the others mentioned above. I'm hopeful that the short-term rental ordinance will be revised to enhance its provisions regarding health and safety, and its enforceability generally. We shall see.

One More Thing: The Village has added a program called Community Connect whereby you can provide certain types of information to the Fire Department to make it easier for them if they have to respond to your house. It includes things like a bare-bones description of your house, number of occupants, whether you have a pet, etc. I've signed up for it and it seems very

useful. While we're on the subject, I again recommend that you sign up for the Village's Code Red reverse notification program which gets activated in times of emergency. Both of these services are accessible on the Village website or on MyVoP.

## Lake Management

Those who have seen the Northern Lights from the lake are so fortunate. Usually, one would have to travel further North to see them. If you missed them, here's a sample and there's more on the LPA Facebook page.






This year, only spot treatments for hydrilla were required. At the end of September, NC Lake Management boated along the entire shoreline and found hydrilla in the shallow coves of Horse Creek, Brae Burn Village, Lake Point Cottages, Diamondhead Dr S. (opposite the marina), Burning Tree Rd and Queens Court. They spot treated these areas and indicated spraying didn't require the suspension of any irrigation. It's unlikely that any further treatments will be needed this year as the water is turning cooler.

Periodically, logs will appear in the lake:







If the beach club/marina is operating, the club manager, Bill Janhonen, can be notified at 203-554-8075 (wjanhonen@wsjenterprises.com) to remove them. If they're not operating, you can

contact me at 732-672-9109. We'll need additional people, as neither of us will always be available. Please contact me to be placed on the volunteer lumberjack list. It's not difficult, but it requires two people and ladies are able to participate. I found the easiest method to move a log in water is to use a bowline on the right side of the pontoon boat, and lasso it around the log about 3 feet from the end. The loop doesn't have to be snug, only tight enough so that it won't pull off with forward motion. The log will rest along the pontoon to the right of the steering wheel. This allows the pontoon driver to monitor it, as they slowly motor to the (dam) shoreline, where it can be beached. Any turns should be gentle rather than sharp.

I contacted Bob Farren about any new information on correcting the minor seepage occurring at the dam. Bob is the Resort's executive responsible for the dam's safety and structure. His response was," We are continuing to work with our Engineering teams along with NCDEQ on the status of the Lake Pinehurst Dam. Progress is being made on further evaluating and prioritizing the scope of the work in order to design the repairs and submit for approval from NCDEQ. Withers and Ravenel, that we have had on retainer for a number of years, has engaged Schabel Engineering for their expertise in addressing the design and permitting phase once a path forward is established. We have no set timeline at this time, but rest assured it is a priority. The best thing to keep in mind is first of all, the dam is well designed in that it has a very adequate emergency overflow in the event of an extraordinary storm event that would otherwise overtop the dam, and secondly we are in regular communication with two of the most respected engineering firms in the SE as they work to manage the situation."

I hope all are enjoying this October weather.
